Peam Bang Sub-district, Stong District, Kompong Thom Province;

NOTING the letter of Mr Karim Khan dated 30 December 2008, which requested his colleague Mr. Alain Werner to participate the Trial Management Meeting to be held on 15-16 January 2009;

HAVING CONSULTED with the Judges of the Trial Chamber;

NOTING THAT pursuant to Article 6 of the Law on the Bar "foreign lawyers may only practice their profession in the territory of the Kingdom of Cambodia with authorization from the Cambodia Bar Council...";

NOTING THAT Mr. Alain Werner has not been recognised by the Bar Association of the Kingdom of Cambodian;

With a view to facilitate the fair and expeditious conduct of the proceeding as well as Parties' interest, including the Accused's;

THEREFORE, THE TRIAL CHAMBER HEREBY DECIDES

TO ALLOW Mr. Alain Werner to participate the Trial Management Meeting to be held on 15-16 January 2009 as an observer;

BASED on your role as mentioned above, you are not allowed to play any remarkable active role in this meeting, such as raising any view, questioning, or responding to any question.
