### I. INTRODUCTION

1. On 27 May 2011, the Ieng Sary Defence filed two Supplement Briefs under Rule 89 (Pardon and Amnesty)<sup>1</sup> and (Ne Bis In Idem)<sup>2</sup>. The Co-Prosecutors responses to the two supplemental briefs are due 6 June 2011.
