1. Below is the finalized Agenda for the Trial Management Meeting to be held on 15 and 16 January 2009 in the main courtroom of the ECCC, in accordance with the "Notification of a Trial Management Meeting and Order to the Parties to File Additional Materials" dated 11 December 2008, and with the proposals for additional agenda items made by the Parties.¹
2. In accordance with Rule 79(9) of the Internal Rules, the meeting will be held without the presence of the public and information discussed therein shall be confidential unless otherwise provided by the Trial Chamber.
3. Due to the mere technical and procedural nature of the Agenda items, the Accused person will not be required to attend the Meeting, or any part thereto, if he wishes not to.
4. Sections or Units of the ECCC are required to attend to the specific Agenda items relevant to their activities, while they shall remain on stand-by for all remaining items to provide any information as necessary. They may attend other parts of the Meeting if they wish to.
5. Represented Civil Parties will be allowed to express their views in connection with the Agenda Items, if any, through their lawyers only.
6. Due to limited seating availability, only 10 Civil Parties and 8 Civil Party Lawyers will be allowed to enter the Courtroom. Precedence will be given to those Civil Parties who do not have legal representation. All other Civil Parties and Civil Party Lawyers who wish to attend the Meeting will be accommodated in the public gallery. In this regard, Civil Parties who intend to attend the Meeting or their lawyers shall accordingly inform the Court Management Section no later than Tuesday, 13 January 2009 to allow seating arrangements to be made.
7. Times references in the Agenda are only indicative and the Trial Chamber reserves the right to modify them.
