I, **Judge NIL Nonn**, President of the Trial Chamber of the Extraordinary Chambers in the Courts of Cambodia (“ECCC”);

BEING SEISED of Case File No. 001/18-07-2007-ECCC/TC pursuant to the “Decision on Appeal Against the Closing Order Indicting Kaing Guek Eav Alias Duch,” rendered orally by the Pre-Trial Chamber on 5 December 2008 and filed in Khmer on 9 December 2008;

HAVING RECEIVED on 26 January 2009 an urgent letter from Mr. Karim Khan requesting, *inter alia*, that Civil Party Lawyer Ms. TY Srinna be granted an extension of time to file a list of proposed witnesses and experts to be summoned at trial on behalf of certain Civil Parties in the proceedings (“Request”);

NOTING that Mr. Karim Khan has not completed his registration with the Bar Association of the Kingdom of Cambodia and, hence cannot be considered as a Civil Party Lawyer before the ECCC;

FINDING that, therefore, Mr. Karim Khan has no standing to file the Request;

HEREBY DECLARES the Request inadmissible and accordingly **REJECTS** it. *ES*
