On 31 October 2011, we requested that the Trial Chamber provide, as a matter of courtesy, copies of certain sources cited in its Decision on the Co-Prosecutors' Request to Exclude Armed Conflict Nexus Requirement from the Definition of Crimes Against Humanity which we were unable to locate. The requested sources were listed in footnote 2 of our letter:

In paragraphs 15-16, n. 45-49, the Trial Chamber cited two Control Council Law No. 10 cases that the IENG Sary Defence has been unable to locate online or through the ECCC library: (1) Ohlendorf and Others Case ("Einsatzgruppen" case), Judgement, 8-9 April 1948, reprinted in Trials of War Criminals Before the Nuernberg Military Tribunals under Control Council Law No. 10, Vol. IV, p. 499, and, (2) Ernst von Weizsaecker and Others Case (Ministries Trial), Order of the Tribunal Dismissing Count Four, and Tribunal Memorandum Attached Thereto, 26 March 1948, reprinted in Trials of War Criminals Before the Nuernberg Military Tribunals under Control Council Law No. 10, Vol. XIII, p. 112, 115-117. In paragraph 20, n. 54, the Trial Chamber cited Roger S. Clark, "Crimes Against Humanity in Nuremberg", in The Nuremberg Trial and International Law (Ginsburgs and Kudriavtsev, eds., 1990), p. 177, 195. This book is not available in the ECCC library. In paragraphs 28-29, n. 64-65, the Trial Chamber cited a Commission on Human Rights Report, 23rd Session, 20 February 1967-23 March 1967, p. 45-46, paras. 144-145. The IENG Sary Defence has been unable to locate this document online. In paragraph 30, n. 67, the Trial Chamber cited UN Doc. A/C.3/SR.1863, 3rd Committee, 1859th Meeting, 9 November 1971, p. 249. The IENG Sary Defence also has been unable to locate this document online.
