THE TRIAL CHAMBER of the Extraordinary Chambers in the Courts of Cambodia (“ECCC”);

BEING SEISED of Case File No. 002/19-09-2007-ECCC/TC pursuant to the Decisions on Appeal Against the Closing Order by IENG Sary, IENG Thirith, NUON Chea and KHIEU Samphan, rendered by the Pre-Trial Chamber on 13 January 2011;¹

NOTING the IENG Sary’s Request for Extension of Time to File his Lists of Documents and Exhibits, which seeks an extension of time for the filing of its lists of documents and exhibits until after the Office of the Co-Prosecutors and Civil Parties have presented their case, or alternately until 60 days from the date the Trial Chamber has informed the parties as to the structure of the trial and the orders of the topics which will be addressed (“IENG Sary Request”);²

NOTING that the KHIEU Samphan Defence also filed a request for extension of time for the filing of its lists of documents and exhibits which is premised upon the same arguments of the IENG Sary Request;³

NOTING that the IENG Sary Request is also joined by the NUON Chea and the IENG Thirith Defence;⁴

NOTING the Chamber’s Order to File Material in Preparation for Trial (E9) which required the parties to file their lists of documents and exhibits by 13 April 2011 (subsequently modified to 19 April 2011 following the announcement of a judicial recess);⁵

CONSIDERING that on 8 February 2011, the Trial Chamber indicated that it would reject all requests to adopt a modified procedure to that envisaged in the Internal Rules;⁶

FURTHER CONSIDERING that the Defence, having been notified of the relevant deadlines ordered by the Trial Chamber since its Order of 17 January 2011 and having had access to the case file since
