- 3. If your request to submit additional evidence does not comply with Internal 108(7), the Supreme Court Chamber may reject the request as invalid. If you attempt to rely on additional evidence during the appeal stage without having filed a corresponding valid request to submit that additional evidence, the Supreme Court Chamber may reject the additional evidence as inadmissible.
- 4. Any request to submit additional evidence must be filed in Khmer and English or French no later than Monday, 28 February 2011. Appellants affected by your request may respond within 15 (fifteen) days of the receipt of notification of the request.
