#### I. INTRODUCTION

- 1. On 18 November 2010, the Co-Lawyers for Mr KAING Guek Eav *alias* Duch ("Co-Lawyers for the Accused") filed an Appeal Brief<sup>1</sup> with the Supreme Court Chamber (the "Chamber") of the Extraordinary Chambers within the Cambodian Courts;
- 2. On 14 January 2011, the Co-Lawyers for the Accused filed with the Chamber a Reply<sup>2</sup> to the Co-Prosecutors' Response, dated 20 December 2010;<sup>3</sup>
- 3. The Co-Lawyers for the Accused refer to the Interoffice Memorandum of the Greffiers of the Chamber, dated 21 February 2011;<sup>4</sup>

#### II. DIRECT RELEVANCE OF THE NEW EVIDENCE

#### A. "Khmer Rouge Prisons"

- 4. "Khmer Rouge Prisons" is the title of a Documentation Centre of Cambodia (DC-Cam) document compiled by Mr PHENG Pong Rasy. Drafted in Khmer, it contains 328 pages listing the 196 security centres which existed throughout Cambodia during the period of Democratic Kampuchea.
- 5. The Co-Lawyers for the Accused would like to inform the Chamber that "Khmer Rouge Prisons" is a new document which is not in Case File 001 and that they attached it as Annex A<sup>5</sup> to the Appeal Brief and as Annex A<sup>6</sup> to the Reply to the Co-Prosecutors' Response, dated 20 December 2010.<sup>7</sup> The National Co-Lawyer for the Accused referred to pages 81 to 83 of the Khmer version of "Khmer Rouge Prisons" dealing with the Chong Chroy [ប៉ុងហ្គេញ] Security

Centre before the Trial Chamber in his opening statement at the substantive hearing of 31 March 2009<sup>8</sup> and in his closing statement at the end of the substantive hearing of 27 November 2009.<sup>9</sup> The Co-Lawyers for the Accused only located the document at the time of the filing of the Appeal Brief.

# B. DC-Cam's conclusion on DUCH's position and function at S-21 presented to the UN Commission of Experts

- 6. DC-Cam submitted a brief to the UN Commission of Experts entitled "The Selected 31 Biographies of Khmer Rouge Leaders and Others, Prepared for the UN Commission of Experts, August-September, 1998" to enable the Commission to prepare its report to the UN Security Council. The brief included a statement on DUCH's position and function prepared by DC-Cam experts.
- 7. The Co-Lawyers for the Accused would also like to inform Chamber that they will be relying on this new document, i.e. the above-noted DC-Cam brief, to highlight DUCH's position and function at S-21 in light of DC-Cam's experts' two-page document (in English) which describes certain individuals as having been DUCH's superiors. This document has not yet been placed on Case File 001 even though the Co-Lawyers for the Accused attached it as Annex A to the Appeal Brief. The Co-Lawyers for the Accused only recently located the document entitled "The Selected 31 Biographies of the Khmer Rouge Leaders and Others, Prepared for the UN Commission of Experts, August-September, 1998" at the time of the filing of the Appeal Brief.

### C. Additional documents attached to the Appeal Brief and the Reply

8. The Co-Lawyers for the Accused would like to inform the Chamber that they have attached new documents, 11 other than those referred to in sections A and B above, to the Appeal

#### III. **REQUEST**

- 9. The Co-Lawyers for the Accused request that the following new evidence be placed on Case File 001/18-07-2007 ECCC/SCC:
  - A. The 328-page DC-Cam Khmer document entitled "Khmer Rouge Prisons" compiled by Mr PHENG Pong Rasy.
  - B. The DC-Cam brief submitted to the UN Commission of Experts, entitled "The Selected 31 Biographies of Khmer Rouge Leaders and Others, Prepared for the UN Commission of Experts, August-September, 1998".
