**THE SUPREME COURT CHAMBER** of the Extraordinary Chambers in the Courts of Cambodia ("ECCC"):

**RECALLING** the request made by the Co-Lawyers for Civil Parties Group 1 during Day 3 of the Appeal Hearing, 30 March 2011, to admit one confirmation letter as additional evidence in support of the appeal by LY Hor (E2/61), and the oral decision on the same date by the President of the Chamber to admit the confirmation letter as additional evidence;

**RECALLING** the request made by the Co-Lawyers for Civil Parties Group 3 during Day 3 of the Appeal Hearing, 30 March 2011, to admit one confirmation letter and one photograph as additional evidence in support of the appeal by MORN Sothea (E2/82), and the oral decision on the same date by the President of the Chamber to admit the confirmation letter and photograph as additional evidence;

FOR THE FOREGOING REASONS, the Supreme Court Chamber:

**DECIDES** to file the three items of additional evidence as annexes to the present Decision;

**ORDERS** the Court Management Section of the ECCC to file the three items of additional evidence accordingly.
