

**THE PRE-TRIAL CHAMBER** of the Extraordinary Chambers in the Courts of Cambodia ("ECCC") observes that the Closing Order for Case 002 was issued on 15 September 2010 and notified on 16 September 2010<sup>1</sup>. The defence of KHIEU Samphan has appealed the Closing Order in the Memoire en Appel Contre L'Ordonnance de Cloture ("the Appeal") on 21 October 2010.<sup>2</sup> The Appeal was notified on 25 October 2010.

- The Pre-Trial Chamber has identified that the French language version of the Closing Order contains 5419 footnotes. The footnotes are in the English language.
- 2. The Greffier of the Co-Investigating Judges has referred the Pre-Trial Chamber to the Interpretation and Translation Unit (ITU) for consideration of all inquiries related to the translation of the footnotes in the Closing Order into the French language.<sup>3</sup>

# THE PRE-TRIAL CHAMBER THEREFORE ISSUES THE FOLLOWING ORDER AND DIRECTION:

- The Pre-Trial Chamber hereby orders ITU to translate all footnotes in the Closing Order into the French language. The deadline for completing translation of the footnotes into the French language and providing the revised Closing Order with all footnotes in the French language to the parties is 18 November 2010.
- 2. The Pre-Trial Chamber further orders that the Senior Coordinator or Head of the ITU, or their representative, apprise the Pre-Trial Chamber of the status of translation of the footnotes into the French language on a weekly basis, commencing on 1 November 2010.
- 3. The Pre-Trial Chamber hereby grants to the defence of KHIEU Samphan, a period not in excess of fifteen (15) calendar days commencing on the date that the revised French language Closing Order with all footnotes in the French language is made available to the parties, to make any additional arguments that are expressly permitted by Rule 74(3)(a) of the Internal Rules. The page limit for such additional arguments shall be 30 pages. For the avoidance of doubt, the Pre-Trial Chamber further clarifies that the defence of KHIEU Samphan is afforded the opportunity to make such additional arguments on appeal but is not compelled to do so.
