1. **THE PRE-TRIAL CHAMBER** of the Extraordinary Chambers in the Courts of Cambodia (“ECCC”) notes the “Appeal Brief against the Provisional Detention Order of 19 November 2007” filed on 21 December 2007 by the Co-Lawyers for Khieu Samphan.
2. In accordance with the “Ruling on the Defence’s Request for a public hearing on the Appeal against Provisional Detention Order and on the Co-Prosecutors’ Request for Redaction of the Defence’s Appeal Brief” of 3 March 2008, the hearing in this case will be conducted *in camera*, except for such parts that might involve discussion of the grounds for provisional detention under Rule 63(3)(b) of the Internal Rules, which will be held in **public**.
3. It is noted that there has been no involvement of the Civil Parties so far in this appeal and that they might be notified of their rights, if any, after the Pre-Trial Chamber’s decision on civil party participation in provisional detention appeals has been rendered.

THEREFORE, THE PRE-TRIAL CHAMBER HEREBY SCHEDULES the hearing for **23 April 2008** commencing at **9:30 am.** on
