ADDENDUM TO THE SUPPLEMENTARY AGREEMENT BETWEEN THE UNITED NATIONS AND THE ROYAL GOVERNMENT OF CAMBODIA, ANCILLARY TO THE AGREEMENT BETWEEN THE UNITED NATIONS AND THE ROYAL GOVERNMENT OF CAMBODIA CONCERNING THE PROSECUTION UNDER CAMBODIAN LAW OF CRIMES COMMITTED DURING THE PERIOD OF DEMOCRATIC KAMPUCHEA, REGARDING SAFETY AND SECURITY ARRANGEMENTS

RECALLING the Agreement between the United Nations and the Royal Government of Cambodia concerning the prosecution under Cambodian law of crimes committed during the period of Democratic Kampuchea, done on 6 June 2003 at Phnom Penh (hereinafter the "Agreement");

FURTHER RECALLING the Supplementary Agreement between the United Nations and the Royal Government of Cambodia ancillary to the Agreement regarding safety and security arrangements of 14 March 2006 ("the Supplementary Agreement");

NOTING that the size and functions of the Extraordinary Chambers have been reduced significantly pursuant to the Addendum to the Agreement signed by the Royal Government of Cambodia and the United Nations concerning the performance of residual functions, which entered into force on 22 December 2021;

NOTING the completion of judicial proceedings in December 2022, and commencement of residual functions on 1 January 2023;

WHEREAS the parties to the Agreement are convinced that in view of the reduced size and functions of the Extraordinary Chambers the requirements for safety security arrangements under the Supplementary Agreement should be commensurate with such reduced size and functions;

Now therefore the United Nations and the Royal Government of Cambodia agree as follows:

Article 1 – Premises

The Royal Government of Cambodia, pursuant to its responsibilities under Article 14 of the Agreement, will provide at its own expense, designated parts of the premises located at Building 40, Russian Federation Boulevard (street 110), Mittapheap district, 7 Makara commune in Phnom Penh Capital City, as premises of the Extraordinary Chambers for the duration of the residual period.

Article 2 - Security policies and procedures

1. The functions and responsibilities of the International Chief of Security and the Deputy International Chief of Security will hereinafter be performed by the Coordinator of the United Nations Assistance to the Khmer Rouge Trials (UNAKRT).





- 2. The United Nations will provide a security staff member who shall liaise and coordinate day-to-day activities with the Cambodian Chief of Security as well as perform the duties of the International Buildings Supervisor articulated in Article 5, paragraph 2 of the Supplementary Agreement.
- 3. The United Nations shall provide for the performance of the functions of the International Courtroom Security Supervisor, International Security Investigator, International Information Security Officer, international close protection officers and international security officers on an *ad hoc* basis, as operationally required.

Article 3 - Entry into force

This Addendum shall enter into force immediately upon signature.

Article 4 - Termination

The Addendum shall remain in force for as long as the Supplementary Agreement remains in force. It shall terminate when the Supplementary Agreement terminates.
