### News & Notes

## Trial Chamber to Hand Down 1<sup>st</sup> Verdict on 26 July

The Khmer Rouge tribunal will hand down the verdict in its first case against Kaing Guek Eav, alias Duch, on 26 July, the Trial Chamber announced on 24 May.

The verdict will mark the first ever judgment the Extraordinary Chambers in the Courts of Cambodia renders since the court has become operational in February 2006.

Duch, who allegedly headed the notorious security prison S-21 during the Khmer Rouge regime, is charged with

crimes against humanity, war crimes, murder and torture. More than 12,000 prisoners were believed to be dead at S-21 before the regime was toppled in January 1979. The Trial Chamber last year held a public trial and examined evidence and questioned 55 witnesses including 22 Civil Parties in his case, and has since been engaged in judgment drafting for the last six months.

During the 77-day public hearing in Duch's trial, more than 31,000 people came to the court to observe the proceedings. Millions of other people watched live feed from the

court on TVs.

The verdict is expected to be a major milestone for Cambodian people who have waited for justice to be served for more than 30 years.

### **Donors Pledge \$16.5 M for ECCC in New York**

Responding to a call for financial assistance by top officials of the Royall Government of Cambodia and the United Nations, donors on 25 May pledged US\$16.5 million altogether for the Extraordinary Chambers in the Courts of Cambodia to support the court's ongoing cases.

During the pledging conference in New York, among around 60 countries which attended the conference, eight countries made fresh pledges for a total US\$16.5 million to the ECCC, of which \$13.5 million was to the international component and \$3.0 million to the national component.

Top 3 donors are Japan with \$5.26 million including \$2.26 million to the Cambodian side, the USA \$5 million all to the UN side and Australia \$4.48 million including \$0.67 million for Cambodia. The rest of countries pledged include Germany, France, Norway, New Zealand, and Luxemburg. Most of the pledges were made for the 2010 budget.

Donors earlier this year endorsed \$45.5 million for the 2010 budget and another

\$46.8 million for the 2011 budget, all inclusive of contingency. Prior to the conference, the court faced a shortfall of \$21.1 million for this year, including at least \$6.5 million for the national component, and almost the total budget of \$46.8 million for 2011.

Secretary-General Ban Ki-moon appealed to donors to provide urgent funding to the tribunal. "Both components urgently need further funds," Mr. Ban said in his remarks. "They are vital part of efforts to secure Cambodia's long-term well-being, and a crucial element in the world's quest to strengthen international criminal justice.

With the fresh pledges, the court's budgetary shortfall is now \$36.2 million for the international side and \$12.9 million for the national side for the period 2010/2011.

Although the new pledges alone can not fill the shortfall even for this year, the ECCC is grateful for the donors' generosity. Acting Director Tony Kranh and his deputy Knut Rosandhaug, both of who attended the conference, expressed their deep appreciation for donors, welcoming "[UN member] states' strong statements of their ongoing political support for the ECCC."

### **PTC Dismisses Detention Extension Appeals**

The Pre-Trial Chamber of the Extraordinary Chambers in the Courts of Cambodia (ECCC) on 30 April dismissed appeals lodged by the charged persons leng Sary, Khieu Samphan and leng Thirith against three orders extending the periods of their respective provisional detention.

In its three decisions read out in public hearings, the chamber said that provisional detention is a necessary measure to preserve public order in all three appeals. For leng Sary, former Minister of Foreign Affairs during the Democratic Kampuchea regime, the chamber also found that he should remain detained to prevent him from fleeing as well as protect his security.

For Khieu Samphan, who was Head of State under the Khmer Rouge, the chamber found that provisional detention is deemed necessary to protect his security. For leng Thirith, former Minister of Social Action, the chamber said that provisional detention would prevent her from exerting pressure on witnesses or destroying evidence as well as prevent her from fleeing.

All the three are charged with genocide,

crimes against humanity and war crimes in international law, and murder, torture and religious persecution under Cambodian law. Both leng Sary and leng Thirith were arrested on 12 November 2007 while Khieu Samphan was arrested on 19 November 2007. All of them were initially placed provisional detention for one year and subsequently extended twice by orders from Co-Investigating Judges.

With these decisions, all the three would remain detained until the expiry dates of their respective detention periods. If the Co-Investigating Judges issue a Closing Order before the date and indict the charged persons, the judges may order the indicted persons to remain in provisional detention until they are brought before the Trial Chamber.

# Judicial Updates

### **Pre-Trial Chamber**

The Pre-Trial Chamber decided on 16 cases and disposed of a number of procedural and other case-management matters in a month from 20 April through 20 May.

Decisions made are cases of PTC30, PTC31, PTC32, PTC33, PTC34, PTC35, PTC36, PTC37, PTC38, PTC39, PTC40, PTC43, PTC45, PTC47 and 48, PTC08. (See details of the decisions in the Court Calendar, page 8)

At the conclusion of the reporting period, the Pre-Trial Chamber remained seized of 23 other appeals and three applications.

Pending appeals:

- 8 appeals against Co-Investigating Judges' orders on requests for investigative action filed by the parties,
- 2 pending appeals against orders on requests to summon witnesses,
- 1 appeal against an order rejecting a request for annulment of all investigations,
- 1 appeal against an order rejecting a request for stay of proceedings,
- 1 appeal by the civil parties against an order on request to interview persons named in the forced marriage and enforced disappearance requests for investigative action,
- 1 civil party appeal pending against an order on inadmissibility of civil party applications,
- 1 appeal against an order on request for appointment of additional demographic expert,
- 1 appeal pending against an order issuing warning to Defence Counsel,
- 1 appeal against an order on a Defence motion against application of command responsibility in ECCC,
- 1 appeal against an order concerning a Defence request to accept documents relating to the Charged Person activities during the Democratic Kampuchea,



- 1 appeal pending against an order rejecting the conduct of video/audio recordings of Charged Person at the ECCC the Detention Facility,
- 1 appeal against an order rejecting a Defence request for an analytical table of the evidence,
- 1 appeal against an order rejecting a Defence request for 2<sup>nd</sup> expert opinion,
- 1 appeal by the Co-Prosecutors against an order regarding a request to place on Case File additional evidentiary material which, they submit, assists in proving the Charged Persons' knowledge of the crimes,
- 1 appeal against an order on a Defence request for interview of witnesses.

On 11 May 2010 the Pre-Trial Chamber issued Scheduling Orders for hearings in camera on a number of pending appeals for 25-27 May 2010.

Pending applications:

- 2 applications seeking the disqualification of the international Co-Investigating Judge,
- 1 application concerning a request for investigations on a staff member of the Office of the Co-Prosecutors pursuant to Internal Rule 35.

All matters pertain to Case 002.

### **Trial Chamber**

The ECCC's first case against Kaing Guek Eav (alias Duch) closed on 27 November 2009. The Trial Chamber is currently engaged in judgment drafting. The verdict will be pronounced on 26 July 2010.

### Supreme Court Chamber

There are no decisions currently pending before the Supreme Court Chamber. The Chamber is not currently operational.



### Office of the Co-Investigating Judges

#### Investigations

During the month of April, the Office of Co-Investigating Judges continued to conduct its final investigations in Case 002. During the month, four (4)investigative field missions were organized within the boundaries of Cambodia. Co-investigating Judges issued Orders responding to requests from the parties. One order on 'Co-Prosecutors' Request For Investigative Action Regarding Interviews of Nuon Chea And The Film "Enemies Of The People' was made public.

#### **Civil Parties**

The Victims Support Section filed 1,331 civil party applications on the 30 April 2010, bringing the total number of civil party applications to 3,982. After an in-

depth analysis of the situation, the Co-Investigating Judges deem it necessary to allow Civil Party applicants more time for them, to, if necessary, file supplementary information in relation to their Civil Party applications in the light of the press release of 5 November 2009 regarding the seizure of the CoInvestigating Judges in Case 002. Accordingly, applicants have been given an additional time to file supplementary information to the VSS until 30 June 2010 in relation to Civil Party applications that had already been submitted to the VSS up to 29 January 2010.

### Office of the Co-Prosecutors

#### Legal Work

In April 2010, the Office of Co-Prosecutors continued its participation in the judicial investigation and the appellate proceedings in Case File No. 002 in which charged persons DUCH, KHIEU Samphan, IENG Sary, IENG Thirith and NUON Chea are being investigated for crimes described in the Introductory Submission of 18 July 2007.

The OCP filed its responses (1) before the Pre-Trial Chamber to IENG Sary's counsel's appeal against a warning issued to them by the Co-Investigating Judges (9 April), and (2) before the Co-Investigating Judges to IENG Sary's application for investigation against the Co-Prosecutors for conducting allegedly impermissible investigation (19 April).

The OCP also prepared its (1) appeal against the Co-Investigating Judges' order refusing to place evidentiary material on the case file (filed on 4 May), (2) response to IENG Sary's appeal on provision of audio-recording equipment in the Detention Facility (filed on 4 May), and (3) response to IENG Sary's appeal on provision of an analytical evidentiary table with the indictment (filed on 4 May).

Throughout the month, all the members of the OCP including prosecutors, investigators, analysts, case manager, information management staff and interns were engaged principally in the preparation of the OCP's final pre-trial submission to be filed imminently before the Co-Investigating Judges in Case File 002. This document shall contain an analysis of evidence collected in the three years of judicial investigation and the applicable law. This document is expected to run into more than 500 pages and contain more than three thousand substantive footnotes.

#### **Trial Proceedings**

After filing its Final Trial Brief and concluding its final oral submissions, the OCP now awaits the judgment of the

Trial Chamber in Case File No. 001 that dealt with the Khmer Rouge's S-21 Security Centre in Phnom Penh.

#### **Criminal Complaints**

Till date, the OCP has forwarded more than 4,151 criminal complaints to the Co-Investigation for inclusion in Case File 002. These were received from individual complainants through the Victims Support Section.

#### **External Activities and Outreach**

The OCP considers outreach as an important part of its mandate. Therefore, its members regularly take part in outreach efforts organized both by the Court and external agencies. In April 2010, the OCP participated in one such program.



### **Victims Support Section**

#### **Processing CP Applications**

A total of 963 Civil Party applications summarised, translated. were categorised, and edited before 30 April 2010, the deadline set by the Co-Investigating Judges for submission to them of all Civil Party applications. Given that it takes between 2 and 5 hours to process one Civil Party application, the VSS undertook special measures in order to achieve this deadline, drawing in staff from other units of the Court, adding volunteers as well as focussing all of its own staff on meeting this deadline.

As a result, the VSS was able to process and deliver all the remaining 1331 applications to the Court Management Section, on time, on 30 April (see photo). This means that a total of 3,989 Civil Party applications have been submitted in respect of Case 002. Admissibility decisions by the Investigating Judges now lie ahead in respect of almost all of these.

#### Outreach

Earlier in the year, the Co-Investigating Judges also set a deadline of 29 April 2010 as the deadline for submission of supplementary information for Civil Party applications. This is information in addition to that already submitted in the original applications provided to the VSS up to the end of the January deadline for the public. It is in particular useful for applicants who submitted their applications prior to the announcement by the Co-Investigating Judges of the scope of the investigation of Case 002 in November 2010, and who thus were unaware of the link to the investigation that they needed to show in their application.

In view of the 29 April deadline accordingly, a strong campaign was mounted by Civil Party lawyers, VSS outreach staff and intermediary organisations to visit as many Civil Party applicants as possible whose applications were incomplete. Civil Party lawyers and intermediary organisations visited 219 individual applicants in the provinces of Kandal, Kampong Speu, Kampot, Pursat, Svay Rieng and Siem Reap, explaining where their applications were incomplete and seeking the additional information necessary for a complete application. VSS outreach teams also met 43 persons for this purpose in the provinces of Siem Reap, Banteav Meanchey, and Kampong Thom.

In addition, outreach staff provided information to Civil Party applicants and answered their questions regarding court procedures in public forums, one at the Court's premises organised by the Public Affairs Section addressing as many as 300 Civil Parties from Kratie, and a second forum in Anlong Veng, organized by one of the Court's partner organisations, the Centre for Justice and Reconciliation. Upon application by Civil Party lawyers noting the need for legal advice to applicants in this respect, the Co-Investigating Judges extended their deadline for this purpose to 30 June. As a result, this campaign will continue in

earnest throughout May and June.

#### Legal representation

The Internal Rules of the Court, as amended in February, require all Civil Parties to be represented by a lawyer at the latest by the time of the Closing Order. As a rule, this requires each Civil Party to be individually contacted, to have options of legal representation explained, and then to sign powers of attorney authorising the designated lawyer(s) to represent the Civil Party.

Since 66% of Civil Party applicants had not yet given a power of attorney to a lawyer at the beginning of April, outreach teams and Civil Party lawyers and their teams, as well as Intermediary Organisations, have been going out into the provinces to meet with as many unrepresented Civil Party applicants as possible to explain to them their options in this respect and to collect their corresponding powers of attorney.

An additional 509 Civil Party applicants designated powers of attorney in this manner in the course of this month. As a result, as of the beginning of May 2010, a total of 2,213 Civil Party applicants now have lawyers, covering more than 50 percent of all applicants, and this work will continue through the month of May. The Co-Investigating Judges having announced that they wish to have all Civil Parties represented by June. This will be a priority area for the VSS.

# Former War Correspondents Visit ECCC

In their first ever Cambodia reunion, an aging group of 37 former war correspondents who covered Cambodian conflict in the 1970s on 23 April came to the ECCC in search of justice and closure.

The group visited the ECCC after paying their respects to Cambodian and international journalists who were killed during the civil conflict in 1970-1975 and following the Khmer Rouge regime. Acting Director of Administration Tony Kranh and his deputy Knut Rosandhaug addressed them and hosted a luncheon at the court.

Among the former journalists were Americans Glenn MacDonald and Dan Cameron Rodill. The two have been friends for 40 years since they covered Cambodia and Vietnam during the 1960s and 1970s. Mr. MacDonald was an army combat correspondent for ABC News and later did freelance work and Mr. Rodill a reporter for the Chicago Sun Times, Newsday and CBS News.

Although both men have returned to Cambodia and Phnom Penh on numerous occasions, this marked something special for them and all of those who were able to attend.

"It's a great experience," said Mr. Rodill of returning to Phnom Penh with

former colleagues. "We are living history of that period."

During the Cambodian conflict, 37 journalists were killed or are still missingin-action and another 31 Cambodian journalists reportedly died during the Khmer Rouge era. A few families and friends of the dead and missing joined the reunion in remembering those who were lost in the 1970s.

"I have been searching all my life why others died and I didn't," said Mr. MacDonald, mentioning it was his last trip to Cambodia due to poor health. "I don't think I will ever get the answer in this world."

Since the death and destruction hits so close to home, many of the former war correspondents have been following the Khmer Rouge trials and work of the ECCC.

"[The ECCC] wasn't as easy to

understand as people expected," said Elizabeth Becker, former Washington Post and Newsweek correspondent in Cambodia before the Khmer Rouge. "It is more complex than people realize."

Both Ms. Becker and Mr. MacDonald expressed disappointment with the limited number of defendants accused of crimes during the Khmer Rouge era. But Ms. Becker quickly pointed out that she was impressed by the "dedication of the staff."

From his experience in Cambodia, Mr. Rodill said he can understand the feelings of Cambodian people. After 35 years of putting bad memories aside, Mr. Rodill said he is also filled with "memory holes."

"The point of the whole tribunal is trying to get those terrible memories into the light," he explained. "I wish the court full success in doing it."

PTC in its decision declared that: (i) it had not assembled an affirmative vote of at least four judges on the ground of appeal alleging that the Co-Investigating Judges erred in law and fact in violating the rights of eight admitted Civil Parties, namely, by declaring them inadmissible without cause; and (ii) thus the Second Impugned Order remained undisturbed on that ground (the separate Judges' Opinions on this matter were attached to the decision). PTC dismissed the Second Appeal in all other respects. (PTC47 and 48)

**30** April **2010** Decision on leng Sary's Appeal against the Co-Investigating Judges' Order on Extension of Provisional Detention pronounced in a public hearing. PTC found the Appeal admissible in its form, affirmed the Co-Investigating Judges' Order with additional reasons, rejected the request for modification of conditions of detention and dismissed the Appeal on its merits. ### New CDP Radio Show Women and the Khmer Rouge

very popular form: radio drama. Recording the voice of professional speakers acting out scenes creates a real life picture. The story evolves around several young women and men who are married by the Khmer Rouge against their wish and follows their fate up to the present.

On the same day the voice of the young passerby was broadcast, a female listener called in and told her story about gang rape allegedly committed by Khmer Rouge solders more than 30 years ago. If he listened to the radio show, he would have changed his opinion.

"I don't think rape happened under the Khmer Rouge." One day in April, a young man on the street in Phnom Penh was interviewed by a radio team about sexual violence during the Democratic Kampuchea regime. The passerby gave a typical answer and walked away.

The vox pop was part of a new radio programme the Cambodian Defenders Project (CDP) in March launched in order to raise awareness on genderbased violence under the Khmer Rouge regime. The Women and the Khmer Rouge Regime show consists of an interview with guest speakers, a call-in, a vox pop and a radio drama.

The passerby's answer demonstrates the widespread belief among Cambodians that sexual crimes were prevented by the policy of the Khmer Rouge to punish any contact between males and females. Stories of rape survivors and witnesses to mass rape before killings give a picture in stark contrast. CDP is using radio - the most popular mass medium in Cambodia - to inform the population on this specific type of crime.

The radio show looks at gender-based crimes from original angles. Interviews with national and international lawyers representing Civil Parties at the ECCC give the audience an insight into the legal questions. Profiles of victims shed light on emotional the psychological and consequences.

"Yes, many couples were forced to marry," one caller explicitly said during one of the live shows. Each broadcast reserves time for the audience to call in and express their opinions or ask questions to the guest speakers. Many of the callers mention forced marriages. They are victims themselves or had relatives who were married by Angkar.
