List of Lawyers

Pursuant to Rule 12 of the Internal Rules of the ECCC adopted on 12 June 2007 and to Article 4.2

of the Practice Direction on Victim Participation 02/2007, lawyers wishing to represent a Civil Parties before the ECCC must apply to be included in the List of lawyers of the Victims Support Section.

Co-Lawyers

The Civil Parties may be represented by two Co-Lawyers, one Cambodian and one foreign. They will choose their representation from the List of Lawyers.

Criteria

Foreign lawyers wishing to represent Civil Parties must meet certain criteria in order to be included in the List of Lawyers of the Victims Support Section. Those criteria are as follows:

- To be a current member in good standing of a recognized association of lawyers of a UN member state.
- To have a degree in law or an equivalent legal or professional qualification.
- To be fluent in Khmer, French or English.
- To have established competence in criminal law and procedure at the international or national level.
- To have relevant working experience in criminal proceedings, as a lawyer, judge or prosecutor, or in some other capacity.
- Not to have been convicted of a serious criminal or disciplinary offence considered to be incompatible with the representing a victim before the ECCC.
- In addition, foreign Co-Lawyers must register with the Bar Association of the Kingdom of Cambodia.


