**ORDER ON CO-PROSECUTOR'S AND CIVIL PARTY LEAD CO-LAWYERS' REQUESTS FOR EXTENSION OF TIME AND PAGE LIMITS**

**THE TRIAL CHAMBER** of the Extraordinary Chambers in the Courts of Cambodia (“ECCC”);

**BEING SEISED** of Case File No. 002/19-09-2007-ECCC/TC pursuant to the Decisions on Appeal Against the Closing Order by Ieng Sary, Ieng Thirith, Nuon Chea and Khieu Samphan,<sup>1</sup> rendered by the Pre-Trial Chamber on 13 January 2011;

**NOTING** the Co-Prosecutor’s Request for an Extension of Time and Page Limit to Respond to Preliminary Objections of the Accused” of 1 March 2011 (E51/5/1), which seeks an extension of time until 21 March 2011 for the filing of its responses to all preliminary objections, and an increase in the permitted page limit for responses to 40 pages (“Co-Prosecutor’s Request”);

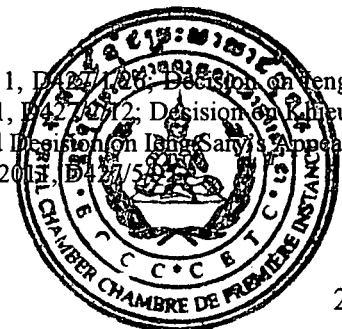
**FURTHER NOTING** the Civil Party Lead Co-Lawyer’s “Demande d’extension des pages aux fins de reponse conjointe aux exceptions preliminaries de toutes les equipes de defence” of 2 March 2011 (E51/5/2), requesting an extension of page limits for the filing of a consolidated response to all Defence teams’ preliminary objections to 25 pages (English or French) and 50 pages (Khmer) (“Civil Party Lead Co-Lawyers’ Request);

**CONSIDERING** the IENG Thirith Defence “Response to ‘Co-Prosecutor’s Request for an Extension of Time and Page Limit to Respond to Preliminary Objections of the Accused’” of 2 March 2011 (E51/5/2), citing the Chamber’s original direction to the parties (E51) and opposing the Co-Prosecutor’s Request, and the Co-Prosecutors’ Reply of 3 March 2011 (E51/5/1/2);

**FURTHER CONSIDERING** its subsequent directions to the parties, which granted an increase in page limits for preliminary objections for two Defence teams of up to 35 pages (English or French), and extended deadlines for these filings until 25 February 2011 and 28 February 2011, respectively (E51/1 and E51/5);

**GRANTS** the Civil Party Lead Co-Lawyers’ Request and permits the filing of a consolidated response to the preliminary objections of all Defence teams of 25 pages in length in English or French and 50 pages in Khmer within the previously-indicated deadline of 7 March 2011;

**GRANTS** in part the Co-Prosecutor's Request and permits the Co-Prosecutors to file a consolidated response the preliminary objections of all Defence teams not exceeding 35 pages (English or French) and 70 pages (Khmer) no later than 21 March 2011 (in two official languages of the ECCC, one of which shall be Khmer);

**CLARIFIES** that replies by Defence teams to these responses, or responses to the preliminary objections filed by the other Defence teams, are not sought by the Chamber. Foti
