

1. On 9 August 2017, the International Co-Prosecutor filed the Appeal against the Closing Order.² On 13 September 2017, the International Co-Prosecutor filed the Request. On 22 September 2017, the Co-Lawyers for **Example 1** filed their Response to the Appeal.³

2. The International Co-Prosecutor requests an extension of time of 15 days to file his reply to the Response.⁴ He underlines the importance of the legal and factual questions raised, the length and complexity of the Response, and his current working resources.⁵

3. Pursuant to Internal Rules 39(2) and (4), the Pre-Trial Chamber may set and/or extend any time limits for the filing of documents relating to an appeal. In the present case, the Pre-Trial Chamber finds appropriate to grant the Request in light of the scope and significance of the factual and legal issues addressed in the Closing Order and the Response.

FOR THESE REASONS, THE PRE-TRIAL CHAMBER UNANIMOUSLY HEREBY:

- **GRANTS** the Request and **ALLOWS** the International Co-Prosecutor to file his reply to the Response in English and Khmer by 16 October 2017.

In accordance with Internal Rule 77(13), the present decision is not subject to appeal.
