- 1. Disagreements between the Co-Investigating Judges ("CIJs") in this case were registered on 22 February 2013, 5 April 2013, 21 October 2015, and 16 January 2017.
- 2. On 20 January 2017, in my Notice of Intention to Add Modes of Liability by way of Judicial Order and of Provisional Discontinuance ("Notice"), I informed the parties of my intention to add additional modes of liability in relation to the crimes charged on 9 December 2015² by way of written order amending the charges.
- 3. In my Notice, I invited the parties to make submissions on the matter.³
- 4. On 1 February 2017, the International Co-Prosecutor filed his Response,⁴ stating that he does not object to the use of a judicial order to amend the charges against Yim Tith.⁵
- 5. Yim Tith did not file any submissions on the matter.

6. **INFORM** YIM Tith of the amended charges as set out in the Annex to this order and that this Annex now sets out the complete charges against him.
