SUBMISSION

1. At 6:00 p.m. on 4 August 2019, Nuon Chea died at the Khmer-Soviet Friendship Hospital in Phnom Penh. In accordance with Rule 32bis of the Internal Rules of the Extraordinary Chambers in the Courts of Cambodia, the Co-Prosecutors are in the process of conducting their investigation into the cause of Nuon Chea's death. In the course of this investigation, staff from the Office of the Co-Prosecutors attended the Khmer-Soviet Friendship Hospital immediately following Nuon Chea's death on 4 August and received Nuon Chea's death certificate from hospital staff at approximately 11:30 p.m. on that date. The Co-Prosecutors hereby submit the death certificate to the Supreme Court Chamber for inclusion in the Case File.²
