The Trial Chamber of the Extraordinary Chambers in the Courts of Cambodia;

**BEING SEIZED** of Case File No. 002/19-09-2007/ECCC/TC pursuant to the Decision on KHIEU Samphan's Appeal against the Closing Order (PTC), D427/4/15, 21 January 2011; the Decision on Appeals by NUON Chea and IENG Thirith against the Closing Order (PTC), D427/2/15 & D427/3/15, 15 February 2011; and the Decision on IENG Sary's Appeal against the Closing Order (PTC), D427/1/30, 11 April 2011;

**RECALLING** the Trial Chamber's statement at the conclusion of the hearings on 23 June 2017 that it would notify the Parties and the public of the date for the pronouncement of the judgement in due course;<sup>1</sup>
