Dear Sir or Madame,

Please allow this statement to supplement parts "B" and "C" of the attached Victim Information Form. This form applies to Case Number 1, which relates to crimes committed in connection to S-21 Security Office (Tuol Sleng), S-24 Security Office (Prey Sar), and Choeung Ek site, that were allegedly committed by Mr. Kaing Guek Eav alias Duch.

My name is Jeffrey James. I am an American living in the United States. My mother's name is Sherry A. Clark. According to documents on file at the Toul Sleng Genocide Museum, as well as documents on file with the Yale Cambodian Genocide Project, her brother (my uncle), James W. Clark, was captured off the coast of Cambodia in April, 1978. James was subsequently taken to Toul Sleng (S-21) prison, tortured, forced to make false statements regarding association with the American CIA, and then murdered. His body was never recovered. According to former guards at Toul Sleng, his body was burned, "so there would be no bones".

I first learned of the crimes committed against my uncle James Clark in 1980 when I was 10 years old. I remember reading an article in Life Magazine (March, 1980) by Steve Robinson detailing the atrocities committed against my uncle. The article was complete with photographs in which my uncle is depicted beaten and malnourished. Information cited in the article, was obtained from Toul Sleng prison records. This information remains of file at the prison. Several and books have been written regarding the capture, torture, and murder of my uncle, all of which reference official documents obtained from Toul Sleng prison records.

I remember my "uncle Jim" quite well before his untimely demise. He would visit our family frequently while I was growing up. We were very close. I always looked up to him. My mother, Sherry A. Clark, my brother, Joshua Rothschild, and myself are the only living relatives of James Clark.

The details of his capture, stories and photographs of his torture and starvation, and his murder have had a profound effect on me. I cannot imagine how any human being could treat another in the manner in which my uncle was treated. The unspeakable acts which



my uncle were forced to endure are unforgivable. I still lie awake at night and imagine the horror my uncle went through. Images of his beaten and ravaged body constantly run through my mind. The person responsible for these acts must be brought to justice.

It is for the reasons mentioned above that I wish to be a civil party in Case Number 1 against Mr. Kaing Guek Eav, alias Duch. I am prepared to furnish evidence in the form of prison records, photographs, and other statements in support of my accusations. I am also prepared to offer copies of birth certificates which will establish my relationship to James Clark.

I know many Cambodians have been deeply affected by the crimes allegedly committed by Mr. Kaing Guek Eav. I hope that the results of the trial will bring those responsible for the atrocities against the Cambodian people, as well as those against my uncle, to justice. In addition, I hope that at the close of the trial, the Cambodian people will be afforded the human rights they deserve.
