Persuant to the above decisions, the Trial Chamber has directed the Office of Administration to provide necessary support to the Medical Unit, Detention Facility and Court Management Section of the ECCC in implementing the experts' recommendations as set out in paragraph 15, 16, 39 and 40 of the Experts' Report on NUON Chea and paragraph 12 (e), 16 and 39 of the Experts' Report on KHIEU Samphan.

The Office of Administration has coordinated with Khmer-Soviet Friendship Hospital, the ECCC Medical Unit and Detention Facility to implement the experts' recommendations. The coordinator designated for the accused treatment project of the Khmer-Soviet Friendship Hospital has confirmed the compliance with the recommendations as detailed in a letter dated 22 May 2014 (attached).

The Office of Administration still maintains this good cooperation with the Khmer-Soviet Friendship Hospital and the ECCC Medical Unit concerning the general health care for the Accuseds in the ECCC Detention Facility.

Please, Mr. President of the Trial Chamber, be informed accordingly.
