#### I. NOTIFICATION

- 1. Disagreements between the Co-Investigating Judges in this case were registered on 22 February 2013, 5 April 2013, 22 January 2015, and 21 October 2015.
- 2. On 8 September 2016, I notified the parties to Case 003 of the placement on Case File 003 of a number of records of the negotiations between the United Nations and the Royal Government of Cambodia for the establishment of the ECCC which contain references to the intended scope of the ECCC's personal jurisdiction. These documents, which were obtained from the United Nations' Archives and Record Management following a request filed by the Meas Muth Defence in Case 003 in November 2015, 1 are also relevant to the investigation of Case 004.

#### FOR THE FOREGOING REASONS, I:

- 3. **INSTRUCT** the Greffier to place on Case File 004:
  - a. the documents listed in the Annex to this decision; and
  - b. the correspondence between the Office of the Co-Investigating Judges and the United Nations for the provision of these documents.

This notification is filed in English, with a Khmer translation to follow.
