


NOTICE OF INTENT TO BE HEARD

1. Pursuant to the direction contained in the Scheduling Order¹ recently issued by the Pre-Trial Chamber (the 'PTC'), counsel for Charged Person Nuon Chea (the 'Defence') hereby gives notice of its intent to submit an oral response to the Co-Prosecutors' Appeal Brief in Response to Co-Investigating Judges' Order Regarding Request to Place on Case File Additional Evidentiary Material Which Assists in Proving the Charged Persons' Knowledge of the Crimes (the 'Appeal').²
2. Additionally, pursuant to Internal Rule 77(6), the Defence requests the PTC to hear the Appeal in public.³ Given the nature and importance of the issues raised by the Appeal, 'it is in the interests of justice [to do so] and it [will] not affect public order or any protective measures authorized by the court'.⁴
3. The Defence looks forward to appearing, as directed, on 26 May 2010 at 2:00 pm.
