Mr. IENG Sary, through his Co-Lawyers (“the Defence”), hereby submits an addendum to his Appeal against the Closing Order.<sup>1</sup> This Addendum provides further support for the preliminary observation made in the Appeal that the ECCC is a domestic Cambodian court.<sup>2</sup> This material was unavailable at the time the Defence filed the Appeal.

1. On 27 October 2010, Mr. Ban Ki-moon, the Secretary-General of the United Nations, participated in a townhall meeting at the ECCC. At this meeting, he stated, “The ECCC has a unique structure among the UN-assisted tribunals. It is a Cambodian court, fully within Cambodian jurisdiction. Yet it has international participation and assistance from the United Nations.”<sup>3</sup>
2. This meeting was attended by Deputy Prime Minister H.E. Dr. Sok An, UN Under-Secretary-General for Legal Affairs and United Nations Legal Counsel Patricia O’Brien, as well as ECCC Judges and other personnel. No one challenged this statement made by Mr. Ban Ki-moon.
