**DECISION ON CO-PROSECUTORS’ REQUEST TO FILE SUPPLEMENTARY SUBMISSIONS
ON THE APPEAL AGAINST THE RELEASE ORDER OF IENG THIRITH**

THE SUPREME COURT CHAMBER of the Extraordinary Chambers in the Courts of Cambodia:

BEING SEISED of the Co-Prosecutors' Immediate Appeal against Decision on Reassessment of Accused Ieng Thirith's Fitness to Stand Trial following the Supreme Court Chamber Decision of 13 December 2011("Immediate Appeal");¹

NOTING the Co-Prosecutors' Request for Extension of Time to File Supplementary Submission in Support of the Immediate Appeal "within seven (7) days" from the filing of the Appeal for the reasons that "[t]he applicable timeframe for appeal has significantly limited the ability of the Co-Prosecutors to provide the Chamber with a comprehensive submission, setting out legal argument in sufficient detail and with references to relevant supporting materials" ("Request");²

CONSIDERING that, in the Impugned Order issued on 13 September 2012, the Trial Chamber has ordered the release of the Accused, who was found unfit to stand trial, and rejected the Co-Prosecutors' request that she be placed under judicial supervision ("Impugned Order");³

CONSIDERING that the Co-Prosecutors do not appeal the Impugned Order's conclusion that the Accused shall be released from the ECCC Detention Facility but only appeal the said order insofar as it rejected their application that the Accused be placed under judicial supervision;⁴

CONSIDERING that the Co-Prosecutors' Request for Stay of the Impugned Order was granted in part only, so the Accused has now been released from the ECCC Detention Facility, under the conditions that she shall (i) surrender her passport and any other travel documents, and remain in the territory of the Kingdom of Cambodia; (ii) inform the Chamber of the address where she will reside and not change residence without prior authorisation from the Chamber; and (iii) obey to any summon issued by the Court;⁵

CONSIDERING that the Immediate Appeal is therefore no longer governed by Internal Rule 82(6) but rather by the procedural regime set out in Internal Rules 107(2) and 108 (4)(bis)(a), which respectively provide for a 15 day time limit to file the appeal and a three (3) month period to decide on such;

PURSANT TO Internal Rule 107(2) (Rev. 8) and Article 8.3 of the Practice Direction on Filing of Documents before the ECCC (Rev. 8);

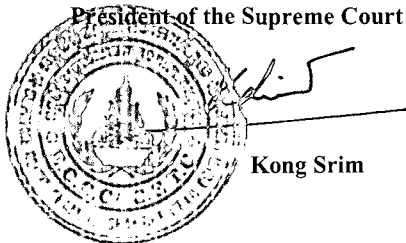
HEREBY:

REMINDS the Accused that any response to the Immediate Appeal must be filed by Monday 8 October 2012.
