Summary of Proceedings:**Request for presentation of evidence by the Co-Prosecutors**

The Co-prosecutors requested time to present a certain number of documents relating to Choeng Ek. The Defence contested the possibility of publicly discussing and showing photographs revealing the identity of protected witnesses, but did not contest the documents as such. The Chamber allowed the Co-Prosecutors to present such evidence, keeping in mind protective measures in place. Documents listed in Documents E53.1, E63.1 and E68.1 to E68.51 were put before the Chamber (see table below).

Questioning of the Accused on the Functioning of S-21, including Choeng Ek, by the Chamber

The Chamber questioned the Accused on the killings at S-21 and Choeng Ek.

Request by the Defence

The defence requested that documents D45/1, D48/1 and D48/2, with annexes, and the videos of the reconstruction at S-21 and Choeng Ek be placed in the E3 folder.

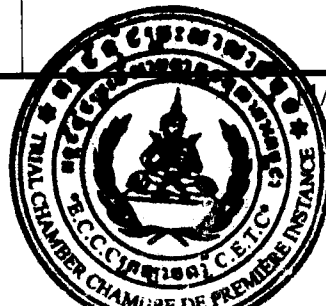
